1. Per reference (a), the Non-Combat Expenditure Allocation (NCEA) for FY05-06 and the Training and Testing Requirement (TTR) for FY07-13 are provided for all Navy ordnance and Marine Corps aviation ordnance. The FY05 NCEA will become effective on 1 October 2004.

2. Procedures for reporting, managing, and augmenting the NCEA are contained in enclosure (1). The list of non-allocated items, by Naval Ammunition Logistics Code (NALC), is contained in enclosure (2). The FY05-06 NCEA and FY07-13 TTR are contained in enclosure (3). To avoid mailing costs, all enclosures will be sent via email by NOLSC AMMO (413.32A).

3. Addressees are requested to provide a point of contact (POC) for NCEA matters to NOLSC AMMO (413.32A), copy to OPNAV (N411), by 1 October 2004. Provide name, office code, message and mailing addresses, and DSN/commercial office and facsimile telephone numbers. Those claimants intending to use e-mail for augment request should provide the above data with each request. If major claimants TTR POCs differ from those responsible for NCEA management, their names, codes, addresses and telephone numbers should be forwarded to CNO (N411).

## REPORTING, MANAGING, AND AUGMENTING NON-COMBAT EXPENDITURE ALLOCATIONS (NCEA)

### 1. General.

a. Allocations provided in enclosure (1) to the basic letter are the total of all Navy, including Marine Corps aviation, ordnance items authorized for expenditure. These allocations may not be exceeded or carried over to subsequent fiscal years. Allocations for Commander, U.S. Atlantic Fleet include all allocations for subordinate units of Commander, U.S. Naval Forces, Europe.

b. Individual storage activities may hold up to 180 days of training assets within CONUS and 365 days OCONUS in accordance with Global Naval Ordnance Positioning Plan guidance. However, **possession of ordnance does not constitute authorization to expend.**

### 2. Reporting.

a. Navy Operational Logistics Support Center, Ammunition (NOLSC AMMO) will notify major claimants when FY05 allocations are loaded into the Conventional Ammunition Integrated Management System (CAIMS), and will specify via separate correspondence the last day expenditure reporting can be recorded against the FY04 NCEA.

b. Major claimants will submit sub-allocation messages to NOLSC AMMO using the format found in attachment (1), or enter the data directly into CAIMS within thirty days of receipt of FY 05 NCEA to ensure proper NCEA accountability. Major claimants and NOLSC AMMO will ensure sub-allocations do not exceed the total major claimant allocation of any given NALC/NALC series.

### 3. Material Issue Policy.

a. NAVSUP P-724 provides first-in/first-out policy. To the extent possible, inventory managers and ordnance activities will issue the oldest and nearest overage material first.

b. Inventory managers and ordnance activities will issue material in Condition Codes B (Serviceable - issuable with qualifications) or C (Serviceable - priority issue) to the greatest extent possible. Condition Code E (Unserviceable - limited restoration) material may be issued with requisitioner's concurrence provided all safety regulations for peacetime use are met.

c. Inventory managers and ordnance activities must use the current NCEA as authorization when processing NCEA requisitions.

#### 4. Augments to Allocations.

a. Major claimants should strive to meet additional requirements by reallocating among sub-claimants within their claimancy or by transferring allocations between major claimants.

(1) Major claimants transferring allocations must submit NCEA augment/decrement request forms as prescribed in paragraph 4.b below by letter, message, or e-mail format.

(2) Allocations transferred for special projects or special qualification tests will be reported to CAIMS when actually expended using procedures established for dual Unit Identification Code (UIC) reporting.

b. As necessary, major claimants may request an allocation augment by submitting message, letter or e-mail requests from competent NCEA authorities to NOLSC AMMO (413.32A) in the format provided in attachment (2). Responses will be promulgated via naval message. NOLSC AMMO PLAD is NAVAMMOLOGCEN MECHANICSBURG PA.

#### 5. Mid-year Review of NCEA.

a. Major claimants should conduct mid-year reviews of NCEA expenditures to date and anticipated expenditures for the balance of the fiscal year. This review will assess local NCEA posture and form the basis for augment/turn in requests. Major claimants are encouraged to continue the practice of continual assessments throughout the fiscal year. The focus of the mid-year review is to address significant issues such as review of critical items, Navy Ammunition Reclassification (NAR), and other issues that could affect training for the last two quarters of the FY. Turn-in of excess sub-allocations can be processed any time during the fiscal year. However, good sense should prevail to preclude later augment requests for any items that were turned in.

b. Recommended changes will be forwarded to NOLSC AMMO (413.32A) by 15 March 2005.

6. Data call for Training and Testing Requirements (TTR) and Conference.

a. Major claimants will submit TTR to NOLSC AMMO (413.32A) per the direction and guidance provided in the CNO TTR data call memorandum. NOLSC AMMO will consolidate the TTR inputs and provide copies to CNO (N411) and CNO (N780D5A). NOLSC AMMO will then use the TTR to formulate a draft NCEA by 1 December. Resource sponsors will review and make any required adjustments to the final draft.

b. An NCEA conference will be held in the April timeframe to provide major claimants the opportunity to review and comment on resource sponsors' recommended allocations.

c. The completed NCEA will be forwarded to CNO (N411) for final approval.
